

**ORDINANCE NO. O-14-010**

**AN ORDINANCE AMENDING THE CITY OF WOOD DALE NO PARKING  
ORDINANCE CHAPTER 15, ARTICLE XX, SECTIONS 15.2006 OF THE CITY CODE TO  
INCLUDE NO PARKING ON THE NORTH SIDE OF POTTER STREET FROM CLARE CT TO  
50 FEET EAST OF THE INTERSECTION**

**WHEREAS**, the City of Wood Dale is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

**WHEREAS**, the City of Wood Dale is authorized and empowered, under Section 11-80-2 of the Municipal Code, 65 ILCS 11-80-2, to regulate the use of streets and public parking thereon; and

**WHEREAS**, the City has determined that vehicles are parking close to the intersection of Potter St and Clare Ct on the north side; and

**WHEREAS**, due to the curve of the roadway, it is difficult for cars exiting the intersection from the north to adequately see vehicles that are approaching from the east; and

**WHEREAS**, residents have expressed a desire to have an area near this intersection where vehicles are prohibited from parking all the way up to the intersection.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS**, as follows:

**SECTION ONE:** That the recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** That the Code of Ordinances of the City Chapter 15, Appendix XX, Section 15.2006 entitled, "Schedule VI – No Parking at Any Time" shall be amended as provided for herein:

Sec. 15.2006. Schedule VI - No Parking at Any Time.

In accordance with sections 15.1310 and 15.1315 of this Chapter and when signs are erected giving notice thereof, no person shall at any time permit a vehicle to park upon any of the following described streets or parts of streets:
